The Field Operations Supervisor position is responsible for managing and supervising the activities of the Field Staff and Contractors. This individual is available to respond to questions throughout the day, to ensure production goals are achieved, and work performed is in compliance with ECA's program procedures and guidelines. This individual will direct and coordinate field programs to ensure maximum productivity, energy savings, quality assurance and customer satisfaction.

### JOB DESCRIPTION:

- Perform site-visits, audits, and inspections as needed and ensure all work is performed in accordance with company and program guidelines.
- Make recommendations to improve work performance.
- Responsible for managing and maintenance of inventory equipment and materials.
- Maintain relationships with third-party inspectors for field inspections. When necessary, accompany third-party inspectors on on-site visits and mentoring sessions.
- Serve as liaison between contractors and customers to answer questions or resolve complaints.
- Reinforce customer energy education on-site and ensure customer satisfaction.
- Produce daily, weekly, and monthly reports as requested.
- Support safety programs and regulations implemented company wide.
- Ability to perform interior and exterior inspections of residential buildings, including attics and crawl spaces

## JOB QUALIFICATIONS:

### PHYSICAL REQUIREMENTS:
