### General description of duties:

Responsible for installation of weatherization materials according to audit specifications. Materials may include but not limited to: heating systems, caulk, foam, fiberglass, cellulose, windows, doors, and duct work

- General knowledge of installing and evaluation of energy saving devices

## **Duties and responsibilities:**

- Assist field staff in installing needed materials
- Responsible for completion of all weatherization jobs and filing of required reports in a timely and efficient manner
- Maintain accurate records on purchases and inventory jobs
- Provide technical assistance & training in weatherization techniques as required
- Review of required field, client folder and vehicle forms
- Completing needed forms for processing and ordering of needed materials
- Meeting with Weatherization Director on a regular basis to provide production updates and

status reports

- Attending as needed all required trainings and seminars
- Setting up appointments with customers for all necessary visits
- Responsible for accurate testing and reporting of homes with blower door and other testing equipment
- Must communicate with client and provide client education
- All other duties assigned by Weatherization Director or Executive Director

### **Physical Demands:**

- Required to climb a ladder
- Required to crawl into small spaces; situations vary
- Required to use finger-writing implements both manual and electronic
- Required to sit or stand for long periods of time
- Required to speak clearly in person and by telephone
- Required to talk in person and by telephone to obtain and interpret detailed information
- Required to bend, lift and move heavy objects or material
- Required to drive an agency vehicle

### **Environmental Condition:**

- Exposed to weather conditions
- May be exposed to children and adults with contagious illnesses
- May be exposed to lead
- Work in an enclosed area
- Work in families' private homes with variations in temperature, hygiene and living styles
