- Installation of various energy conservation and energy efficiency measures to the building envelope and building systems
- Application standards for these measures
- Verification and commissioning of building envelope and building systems
- Other ancillary standards that might be needed to support these activities, including data collection/analysis/reporting and on-site energy (solar, wind, fuel cells, combined heat and power)
