Core Duties:

Perform home energy audits and inspections, client education, health, and safety testing. Inspect weatherization work in process and provide technical advice and consultation to contractors. Inspect and evaluate heating systems for repair or replacement. Perform quality control inspections of completed weatherization and heating system work to ensure program specifications are met. IRS mileage reimbursement for business trips outside of the normal daily commute, as approved by the Director of Energy Programs.

Core Qualifications: Ability to measure dimensions of residential spaces, including attics, basements, and crawl spaces. Perform mathematical calculations and incorporate program regulations and procedures. Ability to accurately record information, meet deadlines and maintain confidentiality. Ashrae 62-2 2016, LEAD Renovator's Certification, OSHA 10, OSHA confined space, BPI certification (building science principals) preferred, or we will train suitable candidate.
