- Install high-efficiency light bulbs and water conservation devices, as defined by program.
- Using hand-held mobile technology, collect energy usage data, physical characteristics of residential buildings, heating and cooling equipment and appliances; specify recommendations for energy-efficient improvements; and generate reports for the customer and trade allies.
- Track, enter, and report all required program data in an accurate and timely manner.
- Interact politely and meaningfully with homeowners to understand and address their concerns.
- Motivate homeowners to undertake specific energy saving measures based on the findings of the assessment.
- Explain incentives, that may be available, for energy efficiency improvements.
- Provide technical guidance to trade allies for addressing program or residential construction needs or problems. Support and assist contractors in addressing issues onsite in customer homes. May conduct training of contractors or auditors on building science or program requirements.
- Stay current on the latest Program initiatives, policies, and procedures. Propose ideas for improvement. Develop advanced technical knowledge in energy efficiency and building science.
